Destinations: All destinations are weather and conditions permitting. The Captain and Bounty Charters will make all decisions concerning destinations revisions.

Certifications: All person engaging in SCUBA Diving must be a certified diver by a recognized agency or be under the supervision of an Insured and Renewed Instructor with a recognized agency.

Training: All training is to be within the standards of the certifying organization

AM Charters: 7am to 1pm, Island 2 tank Dive (weather dependant)

PM Charters: 2pm to 6pm, local 2 tank Dive

All Day Charters: 7am to 4pm, Island 3 tank Dive (weather dependant)

Night Charters: 7pm to 9pm, local 1 tank Dive

Surcharges: No surcharges at this time.

Open Boat Info: Bounty reserves the right to add additional persons to an "Open Boat" charter

Closed Boat Info: Bounty will not add any additional persons to a "Closed Boat" charter

Group Rosters and Waivers

Final Group Roster and Waivers must be delivered prior to departure.

Cancellations, Payments and Amendments to Policy

Bounty will accept written cancellations only.

Monetary responsibilities in the event of cancellation:

- o 30 days or more to departure: Full refund available, less the non-refundable booking deposit
- o 30 days or less to departure: All monies collected will be forfeited
- o Charters will be canceled if full payment is not received 30 days prior to trip date

Cancellation of the group reservation will ensue and all funds collected will be forfeited under the following circumstances:

- o Failure to deliver funds according to payment schedule. In this event, all funds will be forfeited in accordance with Bounty Charters Cancellation policy.
- o Failure to appear by date and time in contract without proper cancellation procedure as stated in the cancellation policy.

Bounty Charters reserves the right to substitute another vessel, cancel or amend any trip with the occurrence of circumstances beyond our control including but not limited to: inclement weather, government regulation, mechanical failure, and other unforeseen circumstances. If such circumstances arise and cancellation or amendment of the trip occurs there will be a refund issued as deemed necessary.
